PRIVACY POLICY

This Privacy Policy describes how WunderCorp, Inc. (“WunderCorp,” “Company,” “we,” “us,” or “our”) collects, uses, and safeguards information through Wundership.com and any related services we provide through the website (the “Site” and the “Service”). This Privacy Policy is intended to help you understand what information we collect, how we use it, and the choices available to you.

By accessing or using the Site or the Service, you accept this Privacy Policy and the Terms of Use available at <https://wundership.com/terms>, and you consent to our collection, storage, use, and disclosure of your information as described in this Privacy Policy.

WUNDERCORP, INC. PRIVACY POLICY

WunderCorp, Inc. (the “Company”) is committed to maintaining robust privacy protections for its users. Our Privacy Policy (“Privacy Policy”) is designed to help you understand how we collect, use, and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, “Site” refers to the Company’s website, which can be accessed at Wundership.com.

“Service” refers to the Company’s services accessed via the Site, including marketplace features, user accounts, listing functionality, profile functionality, payment-related functionality, and areas where users may create, submit, upload, post, store, or otherwise provide content or information.

The terms “we,” “us,” and “our” refer to WunderCorp, Inc.

“You” refers to you, as a user of our Site or our Service.

By accessing our Site or our Service, you accept our Privacy Policy and Terms of Use (found here: <https://wundership.com/terms>), and you consent to our collection, storage, use, and disclosure of your Personal Information as described in this Privacy Policy.

I. INFORMATION WE COLLECT

We collect “Non-Personal Information” and “Personal Information.”



Non-Personal Information includes information that generally cannot be used on its own to personally identify you, such as aggregated or anonymized usage data, referring and exit pages, URLs, browser type, device type, operating system, approximate geolocation derived from IP address, page views, session activity, and general analytics data.

Personal Information includes information that can identify you personally or that is associated with your account, such as your name, email address, username, account credentials, billing-related information, and any other information you choose to submit through the Site or Service.

1. Information Collected via Technology

When you visit or use the Service, we may automatically collect certain information from your browser, device, or application, including:

- IP address
- browser type and version
- device type and operating system
- referring URL
- pages viewed
- actions taken on the Site
- date and time of access
- session and usage information
- approximate location information derived from IP address

We use cookies and similar technologies to help operate the Service, remember preferences, understand usage, improve performance, and maintain security.

We use Umami Analytics to collect website traffic and usage data. Through Umami, we may collect analytics information such as page views, referring sites, device and browser information, and general usage interactions to better understand how visitors use Wundership.com and to improve the Service.

We may use both persistent and session cookies. Persistent cookies remain on your device after you close your session until they expire or are deleted. Session cookies expire when you close your browser.

2. Information You Provide to Us by Registering for an Account

To access certain features of the Service, you may need to create an account. When you register, we may collect information such as:

- email address
- username
- password or authentication credentials
- profile information you choose to provide

We use Amazon Cognito and Amazon Web Services (“AWS”) to support account registration, authentication, and user pool management. As part of providing these services, account and authentication-related information may be processed and stored through AWS infrastructure and Cognito.

3. Payment Information

If you make or receive payments through the Service, payment-related information may be collected and processed by third-party payment service providers, including Stripe. We do not necessarily store full payment card details on our own servers. Stripe may collect and process payment information, billing details, transaction amounts, and related payment data in accordance with its own privacy policy and legal obligations.

We may receive limited information about transactions from Stripe, such as payment status, partial payment details, customer identifiers, and transaction-related metadata, as needed to operate the Service, maintain records, provide support, prevent fraud, and comply with legal obligations.

4. User Content, Listings, and Public Profiles

Wundership.com allows users to create, submit, upload, post, store, and share content, including marketplace listings and profile information.

Information you choose to make public through the Service may be visible to other users and the public. This may include:

- usernames
- profile information you choose to publish
- listing content
- text, images, descriptions, and other content you submit in connection with items or listings

5. Communications and Support

The Site and the Service are not directed to anyone under the age of 13, and we do not knowingly collect or solicit information from anyone under the age of 13. These parties may access Personal Information only as needed to perform their functions for us and are expected to handle it in accordance with applicable privacy, confidentiality, and security obligations.

In general, we use Personal Information to:

- provide, operate, maintain, and improve the Site and Service
- create and manage user accounts
- authenticate users and secure accounts
- create and display user profiles, usernames, and listings
- process payments and transactions
- communicate with users
- respond to questions and support requests
- send service-related notices and administrative communications
- personalize user experience
- monitor and analyze usage and activity
- detect, investigate, and prevent fraud, abuse, and harmful activity
- enforce our terms, policies, and marketplace rules
- comply with legal obligations

We may also disclose Personal Information if we have a good-faith belief that access, use, preservation, or disclosure of the information is reasonably necessary to:

- comply with applicable law, regulation, legal process, or enforceable governmental request
- enforce our Terms of Use or other agreements and policies
- investigate potential violations
- detect, prevent, or address fraud, security, or technical issues
- protect the rights, property, and safety of WunderCorp, our users, or the public, as required or permitted by law

Non-Personal Information

In general, we use Non-Personal Information to help us improve the Service, analyze trends, administer the Site, and customize the user experience. We may aggregate and anonymize



information so that it no longer identifies an individual and use or disclose that information for lawful business purposes.

Business Transfers

In the event we undergo a business transaction such as a merger, acquisition, reorganization, bankruptcy, financing, due diligence, or sale of all or a portion of our assets, your information may be among the assets transferred or disclosed as part of that transaction. You acknowledge and agree that such transfers may occur and are permitted by this Privacy Policy.

III. HOW WE PROTECT INFORMATION

We implement reasonable administrative, technical, and physical safeguards designed to protect your information from unauthorized access, use, alteration, and disclosure. Your account is protected by your password and authentication controls, and we encourage you to choose a strong password, keep it confidential, and log out after using the Service on shared devices.

We may use security technologies and procedures such as encryption, access controls, firewalls, secure transmission methods, and cloud security controls where appropriate. However, no method of transmission over the Internet or method of electronic storage is completely secure, and we cannot guarantee absolute security.
